# Stay Safe Policy

### ■ Title: Stay Safe Policy

### ■ Introductory Statement and Rationale

#### (a) Introductory Statement

The staff of Bunscoil Chríost Rí formulated this Stay Safe Policy, in consultation with our Board of Management and our Parents, as we believe that the Stay Safe programme is a shared responsibility and their contributions and involvement will be essential to the effective implementation of the Stay Safe programme in the school.

#### (b) Rationale

The Child Abuse Prevention (Stay Safe) programme has been taught in Bunscoil Chríost Rí for many years, and it interlinks with many different areas across the curriculum.

### ■ Vision and Aims

#### a) Vision:

Stay Safe in our school will enable each child to: -

- Recognise and resist abuse or victimisation.
- Equip him/her to have the understanding of who to speak with in times they need help.

**b) Aims:**

The children of Bunscoil Chríost Rí should be enabled to achieve the aims outlined in the Stay Safe Programme, which include:

- To develop children’s self-esteem, assertiveness and self-protective skills.
- To teach children that they should always tell an adult about any situation which they find unsafe, upsetting, threatening, dangerous or abusive.
- To give children the skills necessary to enable them to recognise abuse or bullying.
- To teach the two rules
  - Say no, get away and tell.
  - Never keep a touch a secret.

**■ Content of Plan**

**Curriculum:**

**Stay Safe Programme:**

All primary schools are required to fully implement the Stay Safe programme. The Stay Safe programme for primary schools plays a valuable role in helping children develop the skills necessary to enable them to recognise and resist abuse and potentially abusive situations. (Child Protection Procedures for Primary and Post-Primary Schools 2017, P. 67).

The Stay Safe programme will be taught in Bunscoil Chríost Rí in its entirety as part of the two year cycle of SPHE.

**The Stay Safe Programme 2022 - 2023**

The Stay Safe programme is a personal safety skills programme. In Bunscoil Chríost Rí the programme is a compulsory subject that is taught in all classes. Parental involvement and information is an essential part of the programme and activity sheets are sent home on lessons covered to reinforce the safety skills and messages learnt in school at home. The staff decided that the most effective strategy to cover them effectively is outlined below:

### **First & Second Classes**

### **Third & Fourth Classes**

It was agreed by the teachers that this would create more clarity and make sure that all themes were well covered over the two year cycle.

### **Procedures:**

All staff in this school will follow the recommendations for reporting concerns or disclosures as outlined in the 'Children's First' document, and the department of Educations 'Child Protection Guidelines and Procedures'. (Both can be downloaded at [www.staysafe.ie](http://www.staysafe.ie))

The Board of Management of this school have appointed Eoin Fitzpatrick as the Designated Liaison Person (DLP) and Dan O'Connell as the Deputy Designated Liaison Person (DDL). The staff and management have agreed:

- All concerns will be reported to the DLP in the first instance.
- Each report will be dated and signed.
- A strict adherence to maintaining confidentiality.

### **Best Practice:**

Best practice in child protection is about the school identifying areas of practice which need to be addressed to ensure that children and staff are protected. When children are under the supervision of the school, teachers are considered to be 'in loco parentis'. As a result all staff are aware of their responsibilities in areas of child protection.

#### **1. Physical Contact:**

Physical contact between school personnel and the child should always be in response to the needs of the child and not the needs of the adult. It may be used to comfort, reassure, or assist the child but always open and not secretive and acceptable to the child.

**2. Visitors**

Visitors should never be left alone with pupils. The school will, as so far as possible, vet all visitors.

**3. Children with toileting/care needs:**

If a child has specific care needs, a meeting with parents, principal, teachers, and Special Needs Assistants will be set up to determine how the school will meet the pupils needs. **4. Toileting Accidents:**

Clean underwear and clothes will be available in the school and provided to a child who has an accident. Parents will be informed of any toileting accidents.

**5. Special Education Team:**

Special Education teachers will always work in an open safe environment in their rooms. Special Needs Assistants will work under the direction of the SENCO and class teachers. **6. Changing for games/swimming/PE**

Staff will not be allowed to change with children or help change a child in a cubicle or while they are alone. In situations where privacy is required parents will be asked to assist the child.

Every effort will be made to adhere to our best practice procedures. In the event of an emergency a full written report of the incident will be made to the principal and the parents.

**Staffing:**

In Bunscoil Chríost Rí the recruitment of staff and volunteers is crucial to ensuring that those working with children in the school are safe adults in so far as we can determine. The school always follows correct procedures in hiring, through interviews, references and Garda vetting.

**Children with Different Needs:**

Teachers will endeavour to adapt and modify activities and methodologies in Stay Safe to encourage participation by children with special needs.

The Special Education Teachers will collaborate with Class Teachers to support and supplement the work done in the classroom where necessary.

We will liaise with trained professionals/appropriate agencies when dealing with sensitive issues to ensure that the children involved are fully supported.
